CodeNEXT Update

Last month a District Court Judge ruled that the City violated the law twice while trying to pass a new land use code that would have up-zoned most of the City. The first violation was not notifying homeowners and the second was not allowing a petition process. The land use code would have up-zoned Stillhouse Canyon, including greater height allowances, more impervious cover, and fewer setbacks among other lessened requirements. The City has appealed the ruling, and the code rewrite is on hold.
